### Minutes of the Lottery Advisory Commission April 14, 2020

#### <u>Attendance</u>

A teleconference meeting of the Lottery Advisory Commission (Commission) was held from 3:10 p.m. – 3:24 p.m., on Tuesday, April 14, 2020. Representing the Commission by telephone were Mr. Mike Rud (Chairman), Mr. Russ Hanson, Representative Karla Rose Hanson, Senator Nicole Poolman, and Representative Thomas Beadle. Representing the North Dakota Lottery (Lottery) by telephone were Mr. Randy Miller, director, Mr. Ryan Koppy, sales and marketing manager, Ms. Missy Steele, administrative staff officer, and Ms. Sonja King, administrative assistant. Representing Scientific Games International by telephone was Mr. Bryan Colbert, general manager for North Dakota.

### **Approval of Minutes**

Commissioner R. Hanson made a motion to approve the minutes of the January 28, 2020 meeting. Commissioner Poolman seconded the motion. The motion passed 5-0.

Approval of the Draft Administrative Rules for the Changes to the Powerball Game, Mega Millions Game, and Lotto America Game. (These are emergency rules with declared effective dates as interim final rules of April 8, 2020 and April 9, 2020.)

Mr. Miller presented the draft administrative rules for the changes to the Powerball, Mega Millions and Lotto America games relating to the starting grand prize amount for each game. The rules will no longer include a starting grand prize amount; instead the rules will state the grand prize amount will be determined and announced by each game group. Mr. Miller requested the Lotto America Game draft rules be amended to remove the duplicate word "dollars". Commissioner Poolman made a motion to approve the draft rules as amended. Commissioner K. Hanson seconded the motion. The motion passed 5-0.

Consideration to Offer a Refund to Players that Purchased a North Dakota Lottery "Multi-Draw" Mega Millions Ticket Before April 8, 2020 or "Multi-Draw" Powerball Ticket Before April 9, 2020

Mr. Miller asked the commission for consideration to offer a refund to players who purchased Mega Millions and Powerball tickets prior to the game changes related to the starting grand prize amounts. If refunds are deemed necessary, the specific details of a refund for each game would be determined by Mr. Miller and the assistant attorney general. Commissioner Beadle made a motion to approve the consideration to offer the refunds based on the determination by Mr. Miller and the assistant attorney general. Commissioner R. Hanson seconded the motion. The motion passed 5-0.

### **Omnibus Items**

Mr. Miller stated negotiations are awaiting a response from Scientific Games International, as the Covid-19 crisis has taken the focus from the contract extension. There may be a need for a special Lottery Advisory Commission meeting to approve the contract extension details. Mr. Miller will continue to work with Scientific Games International.

#### Adjournment

Commissioner R. Hanson made a motion to adjourn. Commissioner Beadle seconded the motion. The motion passed 5-0. The meeting adjourned at 3:24 p.m.
